Ranking system* will consider a minimum business from directly sponsored distributors & it's organisation in both organizations for recognition and trips from 1st April 2025.

Terminologies:

Direct Sponsored Distributor: A person recruited by you (sponsor is you, placement could be anywhere)

Indirect Sponsored Distributor: A person recruited by someone else from your LOS but placed under you

Direct Sponsored organization: the organization/ team of the person you sponsored directly

Business from Direct Sponsored team: Any business generated through your direct sponsored distributor and or his/ her organization.

Any rank you have achieved during FY 2024 – 2025 is valid for company sponsored recognition program till Mar 2026. The validity of rank expires after Mar 26.

From 1st Apr 2025, new ranking system is considered for recognition, trip, specific programs or anywhere required other the payout criteria.
